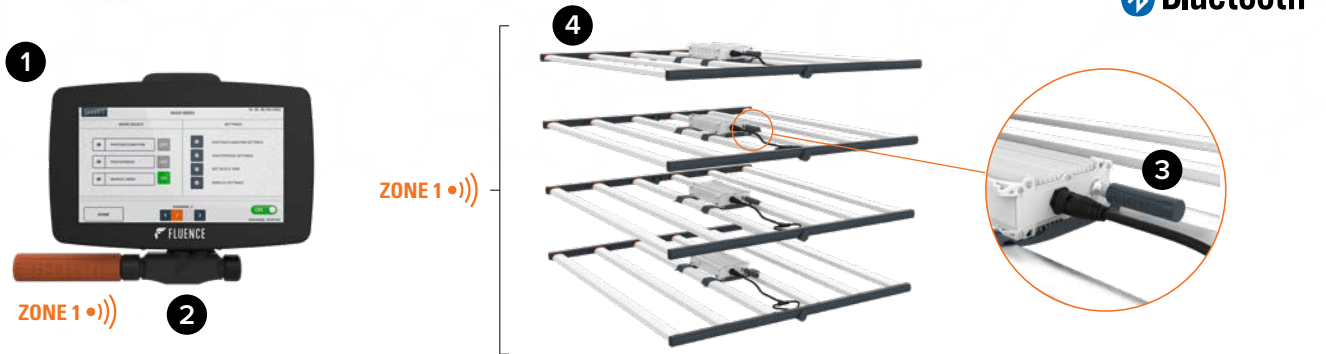

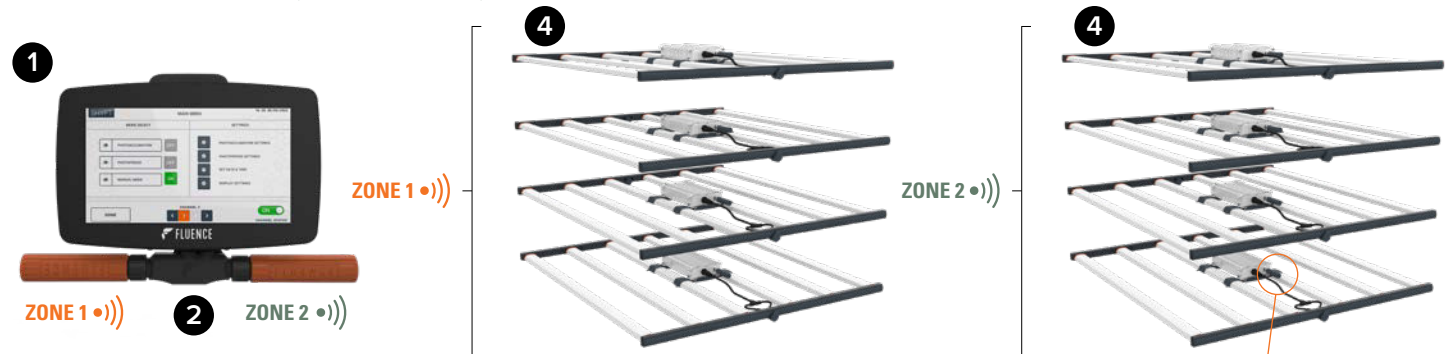
### SYSTEM DIAGRAM (ONE ZONE)

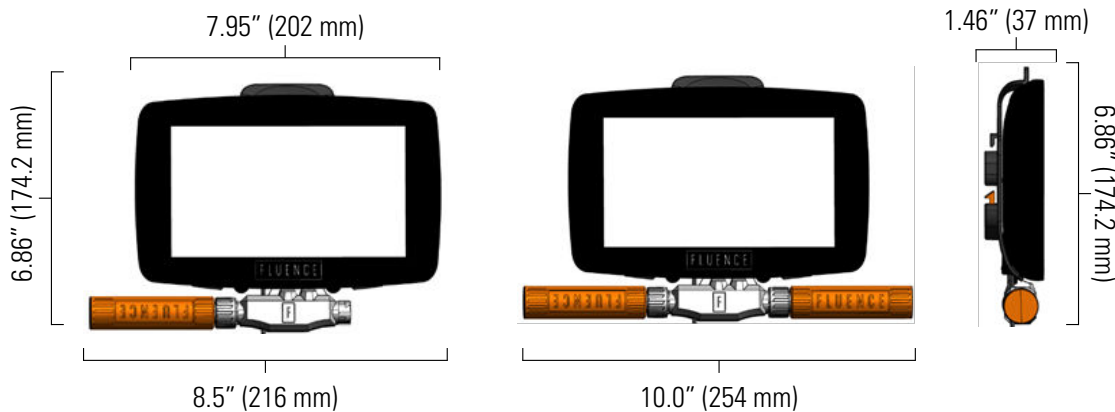

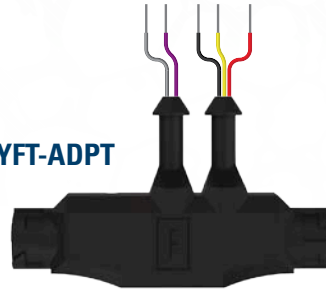
